In our opinion, the accompanying summary financial statements are consistent, in all material respects, with the audited financial statements, in accordance with IFRS Accounting Standards as issued by the international Accounting Standards Board, and the provisions of the Companies and Alled Matters Act 2020, the Banks and Other Financial Institutions Act (807/AJ 2020, and circulars issued by the Central Bank of Nigeria (CBN) and in compliance with the Financial Reporting Council of Nigeria (Amendment) Act, 2023.

Summary Financial Statements
The summary Financial Statements do not contain all the disclosures required by the IFRS Accounting
Standards as issued by the international Accounting Standards Board, the provisions of the Companies
and Allied Matters Act 2020, the Banks and Other Financial Institutions Act (BOFIA) 2020, and circulars
issued by the Central Bank of Nigeria (CR0N) and in compliance with the Financial Reporting Council of
Nigeria (Amendment) Act, 2023, applied in the preparation of the financial statements of the Bank. The
summary Financial statements should be read in conjunction with the audited financial statements.

substitute for reading the audited financial statements and the auditor's report thereon. The summary
financial statements and the audited financial statements do not reflect the effects of events that
occurred subsequent to the date of our report on the audited financial statements.

in compliance with the Financial Reporting Council of Nigeria (Amendment) Act, 2023, and for such
internal control as the Directors determine is necessary to enable the preparation of financial
statements that are free from material misstatements whether due to fraud or error.

 The Bank's statement of financial position, statement of profit or loss and other comprehensive income are in agreement with the books of account.

In compliance with the Banks and Other Financial Institutions Act 2020, and circulars issued by Central Bank of Nigeria, we confirm that:

- Related party transactions and balances are disclosed in Note 27 to the financial statements in compliance with Central Bank of Nigoria Circular 850/1/2004. Ad disclosed in Note 13.2.4 to the financial statements, the Bank and operatives in respect of contraventions of certain sections of the Banks and Other Financial institutions Act 2020 and certain circular issued by the Gentral Bank of Nigoria. Ad disclosed in Note 3.1 to the financial statements, the Bank did not meet the minimum capital requirement of M55blion as 4.3 to December 2020. Subsequent to year end, there was a capital injuried of M55blion as 4.3 to December 2020. Subsequent or Versien did Nigoria.

Based on the requirement of the Financial Reporting Council of Nigeria (FRCN) (Amendment) Act, 2023; the Acting Chief Financial Officer who is one of the Signatories of the financial statements, is not registered yet with FRCN, nor has obtained waiver from FRCN in this requirit, and therefore, does not meet the requirements as stated in FRCN Section 412(2) of the Act.
